**OBSTRUCTION BOND**

**KNOW ALL MEN BY THESE PRESENTS:**

That we, \_\_\_\_\_, as principal, and \_\_\_\_\_, as surety, hereby acknowledge ourselves bound to the City of Sherman, a Municipal Corporation in which the sum of FIVE THOUSAND DOLLARS (\$5,000.00), for the payment of which, well and truly to be made, the said principal binds itself and its successors and the sureties bind themselves, their heirs, executors and administrators, all being bound jointly and severally firmly by these presents.

**THE CONDITION OF THIS OBLIGATION IS SUCH THAT** the above bounden principal desires to do repair and construction work on buildings in the City of Sherman, said buildings being adjacent to and abutting in the various sidewalks and streets in the City of Sherman, and in doing such repair work or construction work it will be necessary to erect scaffolds upon that part of the sidewalks or streets of the City of Sherman lying adjacent to such building to be constructed or repaired in accordance with permission of the City Commission so to do heretofore expressly granted, and

**WHEREAS**, the City Commission has required as a condition precedent to the granting of the said permission that the above bounded principal execute to the said City of Sherman its indemnifying bond payable and conditioned as is this obligation:

**NOW THEREFORE**, if the said \_\_\_\_\_ shall indemnify and save harmless the said City of Sherman from and against all claims, suits, demands, judgements, cost and attorney's fees which shall ever be asserted against it and shall fully pay off and discharge all judgements, demands, claims, and expenses which the said City of Sherman may incur by reason of said obstruction of said sidewalks or streets, or any act which the said \_\_\_\_\_ may do or permit in the enjoyment of the permission granted afore said then this obligation shall become null and void.
